



# Service Agreement

This Service Agreement (the “**Agreement**”) is entered into **DD/MM/YY** by and between **Clients Name** (the “**Customer**”) located at **Clients Address** and **Pass My Prop Firms** (the “**Service Provider**”) located at **Dhaka, Bangladesh**, also individually referred to as the “**Party**”, and collectively the “**Parties**”.

1. **Services:** The Service Provider shall perform the services listed in this Section 1 (the “Services”).
  - 1.1. Pass prop firm evaluation challenge, phase 1 and 2
  - 1.2. Manage the trade account monthly, ongoing
  - 1.3. Invoice for 30% revenue share of profits paid out by the prop firm
2. **Compensation:** The Customer agrees to pay the Service Provider **\$00.00** as payment for engaging in trading services for passing the 2 evaluation phases, as well as 30% of the revenue shared from prop firm payouts weekly/biweekly/monthly for the Services provided.

This fee will be paid in accordance will the following schedule:

3. **Payment:** The Service Provider shall submit an invoice to the Customer on each payout. Invoices shall be paid within 3 days from the date of the invoice. Payments may be made by Crypto or Bank Transfer.
4. **Term:** The term of this Agreement shall commence on the Effective Date, as stated above, and continue, unless otherwise terminated per the terms of this Agreement.
5. **Termination:**
  - 5.1. Either Party may terminate the Agreement at any time upon 7 days prior written notice to the other Party. In the event the Customer terminates the Agreement, the Customer shall still

remain obligated to pay the Service Provider for any Services performed up to the date of termination, prior to the date of termination. In the event the Service Provider terminates the Agreement, the Service Provider shall reimburse the Customer any amounts previously paid to the Service Provider for which the Service Provider has not yet performed the Services.

## 6. Relationship of the Parties.

6.1. **No Exclusivity:** The Parties understand this Agreement is not an exclusive arrangement. The Parties agree they are free to enter into other similar agreements with other parties. The Service Provider agrees the Service Provider will not enter into any agreements that conflict with the Service Provider's obligations under this Agreement.

6.2. **Independent Contractor:** The Service Provider is an independent contractor. Neither Party is an agent, representative, partner, or employee of the other Party.

## 7. Dispute Resolution.

7.1. **Choice of Law:** The Parties agree that this Agreement shall be governed by the State and/or Country in which the duties of this Agreement are expected to take place. In the event that the duties of this Agreement are to take place in multiple States and/or Countries, this Agreement shall be governed by Bangladesh law.

7.2. **Negotiation:** In the event of a dispute, the Parties agree to work towards a resolution through good faith negotiation.

7.3. **Mediation or Binding Arbitration:** In the event that a dispute cannot be resolved through good faith negotiation, the Parties agree to submit to binding mediation or arbitration.

## 8. General.

8.1. **Assignment:** The Parties may not assign their rights and/or obligations under this Agreement.

8.2. **Complete Contract:** This Agreement constitutes the Parties entire understanding of their rights and obligations. This Agreement supersedes any other written or verbal communications between the Parties. Any subsequent changes to this Agreement must be made in writing and signed by both Parties.

8.3. **Severability:** If any section of this Agreement is found to be invalid, illegal, or unenforceable, the rest of this Agreement will still be enforceable.

8.4. **Waiver:** Neither Party can waive any provision of this Agreement, or any rights or obligations under this Agreement, unless agreed to in writing. If any provision, right, or obligation is waived, it is only waived to the extent agreed to in writing.

**9. Notices.**
